

# **The Japan Society of Applied Physics Online Journal Institutional User License Agreement**

## **1. Grant of License**

The Institutional Subscriber (hereinafter referred to as “Subscriber”), having agreed to terms and conditions regulated by this User License Agreement (hereinafter referred to as “Agreement”), shall fill out completely the Institutional Registration Form and submit it to the Japan Society of Applied Physics (hereinafter referred to as “JSAP”). Subscriber shall obtain the right to access online versions of journals with the approval of JSAP. JSAP shall provide online versions of the listed below and license Subscribers to access online versions of journals to which they are subscribing in accordance with the terms and conditions regulated by this agreement.

- Japanese Journal Applied Physics*
- Applied Physics Express*

JSAP reserves the right to add the above list in the event that new journals should become available.

## **2. Copyright**

JSAP shall own the copyright of printed and online versions of each journal listed below.

- Japanese Journal of Applied Physics
- Applied Physics Express

All contents provided as part of the online journal are protected by Copyright Law of Japan and are subject to all the laws and regulations applicable. Copyright notice in JSAP journals and articles may not be removed, altered, or obscured in any way.

## **3. Authorized site and users**

JSAP shall permit Subscribers to access online versions of journals to which they are subscribing via the authorized site for Subscribers. This permission is granted only to subscribers; it cannot be transferred to nonsubscribers nor can the scope of permission be expanded. Under this license, “authorized site” refers to local Internet Protocol (“IP”) address(es) supervised by a single organization (refer to the attached document). With respect to the range of the site, further discussions are to be held between the subscriber and JSAP. “Authorized user” refers to the staff, faculty and students who are registered with the Subscriber at the authorized site and persons granted legal permission to use the IP address(es) of the authorized site.

#### **4. Conditions and restrictions of use**

Subscriber shall be able to access online journals only by the method conforming to the laws and regulations applicable. In principle, subscribers shall be able to browse, save, download or print the online journal for individual use only. For uses other than individual use, subscribers are subject to the regulations stipulated by JSAP.

Systematic or large-volume downloading of online journals (for example, programmatic downloading of all papers published in one issue) is prohibited. Actions impairing the operation of the online journal (for example, abnormally frequent access) are also prohibited.

#### **5. Disclaimer of Warranties**

JSAP shall use reasonable efforts to ensure that JSAP online journals and their contents are complete and accurate. However, JSAP shall not warrant their authenticity, security, accuracy, applicability and usability, and shall not warrant that Subscriber's access to JSAP online will be uninterrupted or error-free, or that online journal service is available in any and all circumstances.

JSAP shall not be liable for any damages arising from using online journal service or not from being available to use the online journals, and shall not be liable for the cutoff connection arising from force majeure including but not limited to, updating data, maintenance of provider, and technical failures.

#### **6. Termination**

JSAP shall have the right at any time to terminate this Agreement forthwith without prior notice in the event of the breach of any of the terms and conditions of the Agreement by Subscriber.

#### **7. General**

This Agreement is subject to change without notice.

## **APPENDIX INSTITUTIONAL IP ADDRESSES / RANGES**

### **Range of IP addresses of subscribing institution**

JSAP shall control access to online journals by institutional subscribers by screening the IP address. Any computer that accesses the Internet has an assigned IP address. The IP address is expressed as four groups of numbers separated by dots (for example, 192.58.150.10). Permissions to access JSAP online journals from the authorized site are granted after evaluating the IP address. Access from computers with IP addresses not within the authorized site is not allowed under this license.

The IP addresses registerable as the authorized site are limited to those officially allotted to each institution. All information on IP addresses provided by each institution is verified by JSAP. In case further information is necessary, JSAP will contact a staff member in charge of institutional subscription in each institution (please inform JSAP of the affiliation, name and e-mail address of this contact). To request online access from more than one site, contact JSAP.
